<u>Director's Report</u>: Circulation number for January include 546 Checkouts, 137 Renewals, and 434 Returns. There were 254 Patrons. 44 people checked out the Coloring to Go Activity, and 195 people attended 24 programs as follows: The Gathering, 70; Craft Time, 24; Littles Story Hour, 59; and Homeschool, 42. Becky and Shane Harvey presented an overview of scanning and entering metadata to interested parties for Recollection Wisconsin January 16, with Margo Busser presenting with them on January 23. An audio recorder will be used in the future to gather information from contributors and the Administrator for the Library Facebook page will be contacted so that history items can be posted on the page. Staff continues to enter books and redo spine labels. The Annual Report has been submitted and will be reviewed for final submission. This summer's program theme is "Adventure Begins at Your Library." In addition to books and DVD's, possible adventures may include a scavenger hunt, kayaking at Devils' Lake, and a hike at Parfrey's Glen. With Becky becoming a Certified Director, she will begin 100 hours Continuing Education.
